	Chinese visa with a renewed foreign passport that does not contain any Chinese visa, you

## Note:

i. If necessary, the applicant may be required to provide other proof documents or supplementary materials. The consular officer will decide on whether to issue the visa and on its validity, duration of stay and number of entries based on the specific conditions of the applicant.

- ii. Starting from June 10th, 2021, the Chinese Visa Application Service Center in Ho Chi Minh City no longer accept old version paper Application form (FormV.2013).
- **iii.** Please visit the website <a href="https://bio.visaforchina.org/SGN2\_EN/">https://bio.visaforchina.org/SGN2\_EN/</a> enter the "Quick Access" section from the homepage, and then select "Start to book an appointment" to make an appointment for visa application. Applicants who have made an appointment need to prepare all the above documents in advance and arrive at the Center 10 minutes before the appointment time.
- **iv.** All applicants aged **between 14 and 70 years old (inclusive)** need to visit the Chinese Visa Application Center to provide their biometric data.
