The proof of the latest legal entry into Kazakhstan and legal stay for more than 180 days in Kazakhstan, for example, the	
original and photocopy of valid visa, legal certificates of residence, employment or student status, or other valid	
certificates of legal stay in Kazakhstan.	

必要时,领事官员可根据情况要求申请人提供其他证明文件或补充材料,或要求与申请人面谈。领事官员根据申请人的具体情况决定是否颁发签证及签证的有效期、停留期限和入境次数。加急服务须经领事官员批准,将加收费用。

If necessary, the consular officer may require the applicant to provide other proof documents or supplementary materials or require an interview with the applicant. The consular officer will decide on whether to issue the visa and on its validity, duration of stay and number of entries in light of specific conditions of the applicant. Express service needs approval of consular officials, and extra fees may apply.
